Legislative: MSgt (Ret) Terry Shannon mentioned HR 4986 Which amends the Family and Medical Leave Act of 1993 to allow the use of leave for any qualifying exigency arising out of the fact that the spouse, son, daughter, or parent of an employee is on active duty (or has been notified of an impending call or order to active duty) in the Armed Forces in support of a contingency operation. Extends such Act to provide leave to employees who are the spouse,

son, daughter, parent or next of kin of a seriously injured service member, in order to care for the member. Extends from 12 to 26 workweeks the leave time available for caregivers of seriously injured service members. Allows an affected employer to require that a request for such leave be supported by a certification of its necessity.
