- 6. Chairman's Comments:

#### Regular:

Sgt Michael Smith read the correspondence from last month which included a thank you letter from NCOA for our donation to the benevolent funds and invitations to various events.

## **Auxiliary:**

Tammy briefed us on the NCOA Business meeting she attended. Everything went well; the HQ building is still up for sale. The meetings will be held in San Antonio for the next 3 -5 years. There was a 65 member growth for the International Auxiliary during the past year.

- 8. Treasurer's Reports: CMSgt (Ret) Jim Kearns passed around the treasurer's report. Balances Regular: \$2,148.26 Auxiliary: \$644.19

## 9. Legislative:

- The Court of Appeals for Veterans Claims recently held that VA regulations defining who had service in Vietnam for the purpose of establishing a presumption to exposure to herbicides (e.g. Agent Orange) were too restrictive. Those who served in Laos, Cambodia, Thailand, or Navy ships off the coast of Vietnam may be eligible for service connection of certain cancers, including lung and prostate cancer as well as type 2 diabetes. Veterans who were previously denied service connection for a presumptive disability should reopen their claim with the VA. Refer to Haas vs. Nicholson No 04-0491 decided August 16, 2006.

#### 10. Unfinished Business:

- a. State Fair support. 55 volunteers on 11 August for the two shifts, thank you all who volunteered. A total of \$1,500 was split between the three organizations. - h. Labor Day Telethon 52 volunteers showed up for the setup and Telethon, 38 from Beale alone. Outstanding support on such short notice. Over \$801,000 was raised. Thanks to all participants. (CLOSED)
